Will dated November 1814 and probated 4 November 1816

Abstract of will of Hannah Guyton:

GUYTON, HANNAH Will Book B, Page 29. Probate Judge Office. Union, S.C. I Hannah Guyton of Union Dist. being in a sick and low condition, but of sound judgement and memory. After my lawful debts are paid. I will to my sister Amey Crittendon my best bed and furniture, the remainder of my est. real and personal be equally divided between my three brothers Isaac, Nathaniel and John Guyton and my two sisters Molley Tat, Amey Crittendin. I appoint my two brothers Isaac and Nathaniel Guyton, executors. Dated \_\_ Nov. 1814. Wit: James McKown, Joseph Ashworth, Nicholas Corry. Signed Hannah X Guyton. Hannah Guyton will proved on oath of Nicholas Corry, before Wm. Rice, Ord. U.D. on the 4 Nov. 1816. Same date qualified Isaac and Nathaniel Guyton executors.

The will of Miss Hannah Guyton lists her sisters, Amy Crittenden and Molly Tate, and brothers, Isaac, Nathaniel and John Guyton. Will written [5] November 1814, probated 4 November 1816, File 8-30, Union County, South Carolina. No final settlement of the estate is shown in the file but buyers at the sale were Isaac Guyton (probably her brother), Mrs Emmy Moor, William Tate junior (possibly the husband of her sister, Molly Guyton), Davis Whelchel, Polly Guyton (probably her niece), James Kennedy and Joseph Manning.

Note:

The will gives her name as " I Hannah Guyton " which indicates that she never married. The will also mentions "my three brothers Isaac Guyton, Nathaniel Guyton and John Guyton" omitting Jacob Guyton which suggests that Jacob Guyton had moved away or died.
