(c 1771 – 1843)

Will dated 2 October 1843 and recorded 24 November 1843

Union County, South Carolina

GUYTON, ISAAC Will Book B, Page 239. Probate Judge Office. Union, S.C. I Isaac Guyton of Union Dist. a planter on Broad River. Getting old in age but of a sound mind and perfect memory. I will and desire my just debts be paid. The rest of my estate lands and tenements, I give and bequeath to my wife Elizabeth Guyton, during her life or widowhood. I give to my sons Jacob and Isaac Guyton one cow and calf, worth ten dollars, and to each household furniture to make them as much as the rest that is married. I leave my dtrs. Sarah and Nancy Guyton the same amount that the rest of my dtrs. recd. After the death of my wife shall be divided between my four sons viz: Nathaniel, Jacob, John, and Isaac and to my five dtrs. Mary, Sarah, Nancy, Hannah, and Elizabeth and the above heirs to pay my daughter Martha Mullinax one twenty five cents. If my dtrs. Sarah and Nancy does not marry they shall have their support from the place, and a house to live in. I appoint my wife Elizabeth Guyton Executrix and Jacob and Isaac Jr. executors. Dated 2 Oct 1843. Wit: Joseph Guyton, James Patrick, Thomas N Cohen. Signed: Isaac Guyton. Proved on oath of Thomas N. Cohen and James Patrick before J.J. Pratt Esq. Ord. on the \_\_ (no date). Recorded 24 Nov. 1843.

Will written 2 October 1843, proven 24 November 1843. Isaac Guyton of Broad River "old in age". Names given in will: Elizabeth Guyton, wife, Jacob Guyton, son and executor, Isaac Guyton, son and executor, "Jacob & Isaac Jr. are to have some cattle & when they marry to have as much as I have given my married sons", Sarah Guyton, daughter, Nancy Guyton, daughter, "Sarah & Nancy are to have \$10.00 each & when they marry they are to have as much as my married daughters". "When my wife Elizabeth dies, all my children equal", Nathaniel, son, Jacob, son, Isaac Jr, son, Mary, daughter, Sarah, daughter, Nancy, daughter, Hannah, daughter, Martha Mullinax, daughter, "and she is to have 25c and no more". Witnesses Joseph Guyton, Jane Patrick, Thomas M Cohen. Appraisers of the estate: Joseph Guyton, George McKeown, Isaac Peeler, John Kennedy, M Montgomery.

There was a second appraisal on 20 October 1856, presumably after the death of his widow, Elizabeth.

There was a later deed dated 28 December 1857 granted to the heirs of Isaac Guyton snr, deceased. This deed mentions Jacob Guyton, who bought the land, Martha Guyton wife of William Mullinax, Hannah Guyton wife of Gabriel Patrick, Elizabeth Guyton wife of Henry M Stroup, Nancy Guyton, Sarah Guyton, Mary Petty who signed by power of attorney, her husband not listed, and J W Guyton. Another son, Isaac Guyton jnr, is not mentioned.
