Guernsey County, Ohio

Administration of the estate of John B Guyton:

To the Honorable, the Judge of the Probate Court of Guernsey County, Ohio:

Your petitioner, administrator of the estate of John Guyton, deceased respectfully represents that valid debts of deceased have already been presented to, and have come to the knowledge of your petitioner amounting to the sum of one thousand (\$1000) dollars (a schedule of which said debts is hereto attached): That the costs of administration will amount to about ----- dollars, and that the total value of the personal estate and effect of said decedent is but \$237.25 being wholly insufficient to pay the debts and costs aforesaid.

Your petitioner further represents that said John Guyton died seized in fee of the following described real estate, situated in the Township of Madison, County of Guernsey, and State of Ohio and known as part of the SE quarter of Section seventeen (17) Township #3 of Range 1 commencing for the same at the NE corner of said section 17; thence W on the N line of said section 17, 162 rods to the NW corner of said section 1 thence S 31 rods and 85 hundredth of a rod; thence E along the Nichols line ninety eight rods; then north 30 rods, thence E 64 rods; thence N to the place of beginning supposed to contain twenty acres more or less.

The said John Guyton leaving Amanda Guyton his widow who is entitled to dower in said premises and the following named persons his heirs at law, having the next estate of inheritance in said premises viz: William Guyton whose place of residence is The Dalles - in the State of Oregon, Jacob Hughes and Ann Hughes, John M. Tederick, Ada Tederick, Erastus Booth, Mary Booth and Catherine Guyton whose respective places of residence are all in said County of Guernsey and State of Ohio.

Your petitioners therefore pray that the said widow and heirs at law may be made defendants to this petition: that the dower of the said Amanda Guyton may be set off and assigned to her in said premises: and that your petitioners may be authorized to sell said premises, or such part thereof as may be necessary to pay said indebtedness. Subject to said dower estate according to the Statute in such case made and provided.

The said John Guyton Deceased, leaving a family, the following articles are not deemed assets, to be administered as such, but left with the family without being appraised, to-wit: The family sewing machine, spinning wheel, one stove and a family Bible and all other books, and pictures and forty dollars in money, twelve head of sheep and all wool shorn from them, all wearing apparel and ornaments of the family desired, all beds, bedsteads and bedding, cooking utensils and tableware, one clock, one side saddle and any other article in value which the widow or if there be no widow the guardian or next friend of such minor child or minor children may elect to be valued by the appraisers and one bay mare selected by the widow.
